20	On October 7, 2021, the assigned magistrate judge entered findings and recommendations,		
21	recommending that "Plaintiff's application to proceed in forma pauperis be DENIED," and that		
22	"Plaintiff be directed to pay the \$402.00 filing fee in full if he wants to proceed with this action."		
23	(Doc. No. 8 at 2.)		
24	Plaintiff was provided an opportunity to file objections to the findings and		
25	recommendations. Plaintiff filed his objections on October 25, 2021. (Doc. No. 9.)		
26	In accordance with the provisions of 28 U.S.C. § 636(b)(1)(C), this court has conducted a		
27	de novo review of the case. Having carefully reviewed the entire file, the court concludes that the		
28	magistrate judge's findings and recommendations are supported by the record and by proper
