**STIPULATION AND ORDER  
CONFIRMING ATTORNEYS' FEES  
AND COSTS FOR THE THIRD  
QUARTER OF 2015**

Judge: Hon. Kendall J. Newman

1 Pursuant to the periodic fees process in this case, Plaintiffs sent their Quarterly  
2 Statement for the Third Quarter of 2015 to Defendants via overnight delivery on  
3 October 28, 2015. The parties completed their meet and confer process on December 4,  
4 2015. The parties have resolved all disputes regarding fees and costs for the Third Quarter  
5 of 2015, with an agreement to reduce claimed amounts to a total of \$548,842.76.

6 THEREFORE, THE PARTIES HEREBY STIPULATE AND AGREE that  
7 \$548,842.76 plus interest is due and collectable as of forty-five days from the date of entry  
8 of this Order. Interest on these fees and costs will run from November 29, 2015 (31 days  
9 after Defendants' receipt of Plaintiffs' statement), accruing at the rate provided by 28  
10 U.S.C. § 1961.


