1	On July 28, 2021, the Special Master filed the required addendum. ECF No. 7251.
2	As required, the addendum (a) clarifies the method used in the Twenty-Eighth Round Monitoring
3	Report to calculate the telepsychiatry vacancy rate reported there; and (b) clarifies what
4	documentation requested by his team to verify custody and mental health staff training required
5	by the custody mental partnership plan was not provided by defendants. With respect to the
6	clarification provided for category (b), the Special Master concluded it was not necessary to
7	revise the Twenty-Eighth Round Monitoring Report. ECF No. 7251 at 8.
8	Consistent with this court's July 14, 2021 order, ECF No. 7229, and good cause
