The Court has not yet ruled on Defendants' motion to stay, and according to its July 12 order, might not do so until after the deadline for Defendants to deposit the first set of fines with the Court on July 25. ECF No. 8329 at 3. Additionally, if the Court rules on the stay motion on July 26, Defendants may not have sufficient time to comply with the Court's order that the second set of fines be deposited by noon that day.

To ensure that Defendants do not have to deposit the fines until after the Court rules on the motion to stay and to allow Defendants sufficient time to deposit the funds after the Court rules on that motion, the parties agree that the court should extend the July 25 and July 26 deadlines to July 29. This deadline would also allow Defendants to seek further relief in the Ninth Circuit, if necessary, after the Court issues its ruling and before depositing the fines with the Court.

Accordingly, the parties jointly request that the Court enter an order extending Defendants' deadline to deposit both sets of fines to July 29, 2024.
