On August 3, 2011, the parties in this case submitted a Stipulation confirming the results of their meet and confer session concerning fees and costs for the First Quarter of 2011, as well as fees from the Third Quarter of 2008 through the Third Quarter of 2010 relating to the motion and appeal on *Comito*/confrontation rights. Pursuant to the Stipulation and Order regarding undisputed attorneys' fees and costs for the First Quarter of 2010, a dispute over plaintiffs' counsel's rates has been held in abeyance. Certain specific hours from the First Quarter of 2011 remain in dispute, as do Plaintiffs' rates above their 2008 rates.
