1 On September 11, 2013, this Court partially granted Plaintiffs' motion for
2 reconsideration of its July 3, 2013 Order finding the case moot, and directed the parties to
3 take certain steps pursuant to its Order. The parties completed those steps timely, and the
4 Court issued an order on November 21, 2013, terminating the decree in this matter and
5 closing the case. On November 25, 2013, the parties completed meeting and conferring
6 regarding fees and costs related to the final revocation proceedings, motions practice, and
7 the currently pending Ninth Circuit appeal. The parties agree to settle all such fees and
8 costs for the amount of \$72,500.00. The parties therefore jointly request that the Court
9 approve this Stipulation and form of order as follows:

10 WHEREFORE, IT IS CONFIRMED that \$72,500.00 plus interest accruing at the
11 rate provided by 28 U.S.C. § 1961 is due and collectable as of forty-five days from the date
12 of entry of this Order.
