- 5 3) The portion of Claim 104 based on the newly discovered tape-recorded conversation
6 between Petitioner and Gabryelski (3d Am. Petn. at 669, ¶ 2257 n. 206), including the
7 claim of ineffective assistance of counsel (3d Am. Petn. at 672, ¶ 2265);
- 8 4) Claim 117; and
- 9 5) Claim 118.
