 23 issues have been tried or heard and a decision has been rendered.

 25 IT IS ORDERED AND ADJUDGED THAT FINAL JUDGMENT IS HEREBY
 26 ENTERED in accordance with the Order Staying Further Proceedings Pending Conclusion of
 27 Related Case of August 14, 2001 (Doc. No. 261), the Memorandum and Order of November 15,
 28 2000 (Doc. No. 255), the Court's Memorandum and Order of June 20, 2006 in the related case,

1 *Cummings v. Connell*, 2006 WL 1716160 (E.D. Cal. 2006) (*Cummings* Doc. No. 270), and the
2 Amended Judgment therein (*Cummings* Doc. No. 272). IT IS FURTHER ORDERED that
3 Plaintiffs motion for entry of judgment be, and the same hereby is, GRANTED with respect to
4 the Original, Amended, and January notices. Final judgment is therefore entered in favor of
5 Defendants and against Plaintiffs on Counts 1 and 2 of the Complaint, in accordance with the
6 Court's Memorandum and Order of November 15, 2000, granting summary judgment to
7 Defendants on those counts. Final judgment is also therefore entered in favor of Plaintiffs and
8 against Defendant California State Employees Association on Counts 3, 4, 5, 7 and 8 of the
9 Complaint. Final judgment is also therefore entered dismissing as moot Counts 6, 9 and 10 of
10 the Complaint.

11 IT IS FURTHER ORDERED that Plaintiffs and each member of the class they represent
12 are awarded nominal damages to be paid by Defendant California State Employees Association
13 in the amount of \$1.00 to each Plaintiff and each member of the class, on Counts 3, 4, 5, 7 and 8
14 of the Complaint.


