

1 The *Ex Parte* Application of Arezou Mansourian, Lauren Mancuso, and Christine Wing-Si Ng
2 for permission to file a consolidated opposition to the motions for summary judgment filed by
3 defendants Robert Franks, Greg Warzecka, Larry Vanderhoef, Larry Swanson, and Pam Gill-Fisher
4 (“Individual Defendants”) and to file a single memorandum of points and authorities to address the
5 motions of the Individual Defendants that exceeds the Court’s 20 page-limit but which is not more than
6 50 pages was considered on an *ex parte* basis. The Court reviewed the *Ex Parte* Application and has
7 found good cause to grant Plaintiffs’ request for a page extension.

8 Accordingly, **IT IS HEREBY ORDERED** that Plaintiffs Arezou Mansourian, Lauren Mancuso,
9 and Christine Wing-Si Ng shall be permitted to file a consolidated opposition to the motions for
10 summary judgment filed by the Individual Defendants and to file a single memorandum of points and
11 authorities to address the motions of the Individual Defendants that exceeds the Court’s 20 page-limit
12 but which is not more than 50 pages.
