19 Whereas on July 1, 2010, this Court granted the parties stipulated agreement that
 20 Petitioner be supervised by the United States Pretrial Services Office of the Eastern District of
 21 California, Docket entry no. 75;

22 Whereas the Respondents' appeal in this matter is now complete as the mandate
 23 spread on June 28, 2011. Docket entry no. 89;

24 Whereas the California Board of Parole Hearings on August 19, 2011, determined
 25 that Petitioner is suitable for parole and state parole authority has accepted and taken Petitioner
 26 under its parole supervision:

 28 attorney, the Office of the Federal Defender and its attorney, ANN C. M^cCLINTOCK, Assistant

1 Federal Defender, and Respondents and their attorney Supervising Deputy Attorney General
2 JENNIFER A. NEILL, that supervision of Petitioner by U.S. Pretrial Services is now longer
3 needed and should be terminated.
