1           1.     The Court deferred ruling on Defendant Naku's motion to  
2 exclude and redact irrelevant and prejudicial testimony until the  
3 time of trial.

4           2.     The Court granted Plaintiff's motion to preclude  
5 evidence relating to Plaintiff's underlying conviction for  
6 domestic violence and citizenship, immigration status or  
7 deportation to or current place of residence.

8           3.     The Court denied Plaintiff's supplemental witness list.

9           4.     The Court denied Plaintiff's request for judicial  
10 notice of the Life Table for Hispanic Males.
