16	Plaintiff is a state prisoner proceeding without counsel in an action brought under 42
17	U.S.C. § 1983. On July 16, 2009, defendant Solomon filed a motion to dismiss. See Fed. R.
18	Civ. P. 12(b). Plaintiff has not filed an opposition or a statement of no opposition to the motion.
19	In cases in which one party is incarcerated and proceeding without counsel, motions
20	ordinarily are submitted on the record without oral argument. Local Rule 78-230(m).
21	"Opposition, if any, to the granting of the motion shall be served and filed with the Clerk by the
22	responding party not more than eighteen (18) days, plus three (3) days for mailing or electronic
23	service, after the date of service of the motion." Id. A responding party's failure "to file written
24	opposition or to file a statement of no opposition may be deemed a waiver of any opposition to
25	the granting of the motion and may result in the imposition of sanctions." Id. Furthermore, a
26	party's failure to comply with any order or with the Local Rules "may be grounds for imposition

of any and all sanctions authorized by statute or Rule or within the inherent power of the Court." 1 2 Local Rule 11-110. The court may recommend that an action be dismissed with or without 3 prejudice, as appropriate, if a party disobeys an order or the Local Rules. See Ferdik v. Bonzelet, 4 963 F.2d 1258, 1252 (9th Cir. 1992) (district court did not abuse discretion in dismissing pro se 5 plaintiff's complaint for failing to obey an order to re-file an amended complaint to comply with Federal Rules of Civil Procedure); Carey v. King, 856 F.2d 1439, 1440-41 (9th Cir. 1988) 6 7 (dismissal for *pro se* plaintiff's failure to comply with local rule regarding notice of change of address affirmed); 8

9 On May 5, 2009, the court informed plaintiff of the requirements for filing an opposition
10 to motions, that failure to oppose such a motion may be deemed a waiver of opposition to the
11 motion and that failure to comply with the Local Rules may result in a recommendation of
12 dismissal.

Accordingly, it is hereby ORDERED that, within 20 days of the date of this order,
plaintiff shall file either an opposition to the motion to dismiss or a statement of no opposition.
Failure to comply with this order will result in a recommendation that this action be dismissed
with respect to defendant Solomon.
