15 Pursuant to Rule 41(a)(1)(A)(ii) of the Federal Rules of Civil Procedure, it is hereby
 16 stipulated by and between plaintiff MARIA SOTO, defendant ENTERPRISE RENT-A-
 17 CAR, defendant TU PHUOC NGUYEN, and defendant GREYHOUND LINES, INC., by
 18 and through their undersigned counsel, that plaintiff MARIA SOTO's complaint is
 19 dismissed with prejudice as to defendant GREYHOUND LINES, INC., only. The
 20 dismissal is based on the fact that a mutually agreed upon settlement has been reached on all
 21 issues between plaintiff MARIA SOTO and defendant GREYHOUND LINES, Inc.
