 18 **IT IS HEREBY STIPULATED** by and between the parties through their  
 19 undersigned counsel, subject to the approval of the Court, that plaintiff be awarded  
 20 attorney's fees and costs under the Equal Access to Justice Act (EAJA), 28 U.S.C.  
 21 Section 2412(d), in the total amount of ONE THOUSAND FOUR HUNDRED AND  
 22 FORTY FIVE DOLLARS (\$ 1,445.00) (i.e., Attorneys fees in the amount of \$1,145.00  
 23 and costs in the amount of \$300.00). This amount represents compensation for all legal  
 24 services rendered on behalf of Plaintiff by counsel in connection with this civil action,  
 25 and all filing fees or other allowable costs, in accordance with 28 U.S.C. Section  
 26 2412(d).

1                   This stipulation constitutes a compromise settlement of Plaintiff's request  
2 for EAJA attorney's fees and costs, and does not constitute an admission of liability on  
3 the part of Defendant under EAJA attorney's fees or costs, and shall constitute a  
4 complete release from and bar to any and all claims Plaintiff may have related to EAJA  
5 fees or costs in connection with this action.

6                   Any payment shall be made out to Plaintiff but delivered to Plaintiff's  
7 Counsel.

8                   This award is without prejudice to the rights of Plaintiff's Counsel to seek  
9 Social Security Act attorney's fees under 42 U.S.C. Section 406, subject to the provisions  
10 of EAJA.
