1 **ORDER**

2 On January 11, 2012, Plaintiffs South Yuba River Citizens League and Friends of the River
3 moved this Court for an order staying the deadlines in Local Rule 293 and Federal Rule of Civil
4 Procedure 54 for the filing of supplemental motions for attorneys' fees until 28 days after the Court rules
5 on the Plaintiffs' main motion for attorneys' fees, which is currently under submission. *See* ECF No.
6 407, 407-1 (Aug. 19, 2011), *see also* ECF No. 433 (Nov. 3, 2011). The Federal Defendants took no
7 position on the motion.

8 Having considered the arguments and good cause appearing, the Court hereby grants the motion.
9 All deadlines for filing supplemental motions for attorneys' fees are hereby stayed. Supplemental
10 motions for attorneys' fees, if any, will be due no later than 28 days after an order on Plaintiffs' motion
11 for attorneys' fees. *See* ECF No. 407, 407-1 (Aug. 19, 2011), *see also* ECF No. 433 (Nov. 3, 2011).

12 The hearing currently scheduled for February 27, 2012 is VACATED.
