ORDER REGARDING CLERK'S
ISSUANCE OF WARRANT FOR ARREST
OF ARTICLES *IN REM*


18 WHEREAS, a Verified Complaint for Forfeiture *In Rem* has been
19 filed on June 14, 2007, in the United States District Court for
20 the Eastern District of California, alleging that the defendant
21 2003 Pontiac Grand Prix, VIN: 1G2WR52163F114111, California
22 License 4ZLC890 (hereafter referred to as "defendant vehicle") is
23 subject to forfeiture to the United States pursuant to 18 U.S.C.
24 § 981(a)(1)(A) for one or more violations of 18 U.S.C. § 1957 and
25 pursuant to 18 U.S.C. § 981(a)(1)(C) for one or more violations
26 of 18 U.S.C. § 1343;

27 And, the Court being satisfied that, based on the Verified
28 Complaint for Forfeiture *In Rem* and the affidavit of Internal

1 Revenue Service-Criminal Investigation Division Special Agent
2 Steven J. Delaney, there is probable cause to believe that the
3 defendant vehicle so described constitutes property that is
4 subject to forfeiture for such violation(s), and that grounds for
5 issuance of a Warrant for Arrest of Articles *In Rem* exist,
6 pursuant to Rule G(3)(b)(i) of the Supplemental Rules for Certain
7 Admiralty and Maritime Claims;

8 IT IS HEREBY ORDERED that the Clerk for the United States
9 District Court, Eastern District of California, shall issue a
10 Warrant for Arrest of Articles *In Rem* for the defendant vehicle.
