 19 Plaintiff United States of America and claimants Wei Jie Ma
 20 and Cindy Woo submit the following Stipulation to Extend Stay and
 21 Order Thereon (Proposed).

22 On September 17, 2007, the parties submitted a joint request
 23 to stay proceedings in this civil action due to criminal charges
 24 pending against Claimant Wei Jie Ma in this district, to wit: one
 25 count of "Conspiracy to Manufacture and Possess with Intent to
 26 Distribute at Least 1,000 Marijuana Plants," and one count of
 27 "Manufacturing at Least 1,000 Marijuana Plants." United States
 28 v. Wei Jie Ma, et al., 2:07-CR-0025 EJJ. Sentencing on those

1 charges is currently pending with respect to Claimant Wei Jie Ma.

2 Accordingly, the parties jointly request that this matter be
3 stayed an additional six months, until January 27, 2012.

4 Assuming that claimant will be sentenced during this time frame,
5 the parties will then ask the court to lift the stay and fully
6 schedule this case.
