19 **RECITALS**

20 The parties named below, through their respective counsel, hereby stipulate and agree
 21 as follows:

22 1. On December 22, 2008, this Court entered the Stipulated Protective Order (Dkt.
 23 45) to govern confidential documents in this case.

24 2. On November 4, 2009, Plaintiffs' and World Savings Bank, FSB, n/k/a
 25 Wachovia Mortgage, FSB, (hereinafter "Wachovia") entered into a confidential Settlement
 26 Agreement and Release resolving their respective claims and defenses in this action which the
 27 parties to the settlement have agreed will be governed by the terms of the Stipulated Protective
 28 Order, and designated as "HIGHLY CONFIDENTIAL – ATTORNEY'S EYES ONLY."

3. Plaintiff's Application for Attorneys' Fees and Costs Pursuant to Settlement and

1 supporting declarations include a copy of the confidential Settlement Agreement and Release
2 and reference the specific terms of the confidential settlement throughout.

3 4. Plaintiffs hereby respectfully request that the Court grant an Order permitting
4 Plaintiffs' to file the Application for Attorneys' Fee Pursuant to Settlement and supporting
5 documents under seal.

6 5. Under the terms of the settlement agreement, Wachovia has the right to oppose
7 Plaintiff's Application for Attorneys' Fees and Costs. Wachovia joins in this request to file
8 documents under seal, and seeks an order that its opposition papers also be filed under seal.

9 6. Transamerican Financial Corporation does not oppose this request, or the
10 designation of the Settlement Agreement and Release as "HIGHLY CONFIDENTIAL –
11 ATTORNEY'S EYES ONLY," for the limited purpose of permitting Plaintiff's Application for
12 Attorneys' Fees and Costs, and any opposing papers, to be filed under seal. Transamerican
13 Financial Corporation does not waive, and reserves its right, to contest the confidential
14 designation of the Settlement Agreement and Release pursuant to the terms of the Stipulated
15 Protective Order.
