 STIPULATION AND ORDER AWARDING
 EAJA ATTORNEY’S FEES

19 IT IS HEREBY STIPULATED by the parties, through their undersigned counsel, subject to the
 20 approval of the Court, that Plaintiff’s counsel, as Plaintiff’s assignee, be awarded attorney fees under the
 21 Equal Access to Justice Act in the amount of FOUR THOUSAND SEVEN HUNDRED TWENTY-
 22 FIVE DOLLARS AND NO/100 CENTS (\$4,725.00). This amount represents compensation for legal
 23 services rendered on behalf of Plaintiff by counsel in connection with this civil action for services
 24 performed before the district court in accordance with 28 U.S.C. § 2412(d).

25 This stipulation constitutes a compromise settlement of Plaintiff’s request for EAJA attorney fees
 26 and does not constitute an admission of liability on the part of Defendant under the EAJA. Payment in
 27 the aforementioned sum under EAJA shall constitute a complete release from and bar to any and all
 28 claims, rights, causes of action, liens or subrogated interests relating to attorneys fees incurred in this

1 action under EAJA.

2 The settlement of Plaintiff's claim for EAJA attorney fees does not preclude Plaintiff's counsel
3 from seeking attorney fees under 42 U.S.C. § 406(b) of the Social Security Act, subject to the offset
4 provisions of the law.
