19 **STIPULATION**

20 On January 10, 2008, the Court entered an agreed judgment permanently enjoining  
21 Defendants Secure Investment Services, Inc., American Financial Services, Inc., and Lyndon  
22 Group, Inc. (collectively “the corporate defendants”) from violations of certain provisions of the  
23 federal securities laws.

24 Plaintiff Securities and Exchange Commission (“Commission”) is now withdrawing its  
25 requests for disgorgement with prejudgment interest and civil money penalties against the  
26 corporate defendants, which are in receivership. The Commission and the corporate defendants  
27 therefore agree to the Court’s entering an order dismissing with prejudice the Commission’s

1 claims for disgorgement with prejudgment interest and civil money penalties against the  
2 corporate defendants.


