The Court having considered the 14 motion, finds the motion should be granted and the scheduled hearing on the motion vacated. 15 16 IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Receiver's 17 motion is GRANTED and the Receiver is authorized, in his discretion, at such time as the 18 receivership estate is required to expend additional funds to pay premiums, to abandon the 19 receivership estate's interest in the life insurance policy number 7430001 in the face amount of 20 \$5 million issued by Travelers Insurance Co., referred to in Receiver's Motion as the PER-T&E 21 Policy. 22 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Receiver is 23 24 authorized, in his discretion, at such time as the receivership estate is required to expend 25 additional funds to pay premiums, to abandon the receivership estate's interest in the life 26 insurance policy number 1289096 in the face amount of \$2 million issued by Security Mutual, 27
