ORDER COMPELLING PAYMENT
OF PREMIUM SHARE FROM LINK
CONSULTING, INC. DEFINED
BENEFIT PENSION PLAN [WIL-
E&C]

15 On this day the Court considered the Receiver's Motion to Compel Payment of Premium
16 Share from Link Consulting, Inc. Defined Benefit Pension Plan [WIL-E&C]. Having carefully
17 considered the Motion and the pleadings and papers on file in this case, the Court is of the
18 opinion, and so finds, that the Motion should be granted. Accordingly,

19 It is ORDERED that Link Consulting, Inc. Defined Benefit Pension Plan shall, within 10
20 days of the date of this Order, pay the Receiver \$208.64 for its share of the premiums.

21 It is FURTHER ORDERED that Link Consulting, Inc. Defined Benefit Pension Plan
22 shall pay the Receiver its percentage share of all additional premium obligations within 10 days
23 of the issuance of a written invoice.

24 It is FURTHER ORDERED that should Link Consulting, Inc. Defined Benefit Pension
25 Plan fail to pay \$208.64 for its share of the premiums or its percentage share of any additional
26 premium obligations as they become due, Link Consulting, Inc. Defined Benefit Pension Plan's
27 0.8181818% ownership and beneficial interest in the WIL-E&C Policy No. 60057369 will



1 automatically be forfeited to the receivership estate and be replaced by an allowed claim for
2 \$10,000.00 in its favor.

3 It is FURTHER ORDERED that in the event Link Consulting, Inc. Defined Benefit
4 Pension Plan's ownership and beneficial interest is forfeited to the receivership estate, then
5 Transamerica Occidental is ORDERED to change its records to reflect and effectuate the
6 transfer.
