a TRO temporary Restraining Order against Defendant Newdow forbidding him from inflicting his own personal policies that is currently endangering my life and Inmates Lives for taking God out of the prisons. Plaintiff seeks \$ 25,000,000.00 Million from Defendant and the return of religious Material at FCI Williamsburg. Plaintiff prays for relief.

Defendant Newdow is in a vast conspiracy with the Bureau of Prisons and FCI Williamsburg to eliminate god in my life since Feb 25th, 2003 when I entered the system.

I have a Constitutional right to do this. Defendant has no authority to tell the warden to stop this constitutional practice. My rights are being violated by Defendant

Defendant Newdow under 36 USC 302 took "In God we trust" away from FCI Williamsburg. "In God we trust" was taken out of prison currency. Defendant is responsible for prison Commissary price gouging because FCI Williamsburg Guards don't have god in them, they are inhumane, and charge 1000% markup prices on expired food that no one can afford. Since FCI Williamsburg don't have god in the facility because defendant took god away I only receive .12⁴ cents a month for working, this is a violation of minimum wage laws. 
