1 It is hereby stipulated by and between Plaintiff, Lary Feezor
2 (“Feezor”), and Defendant, Jeremy Pike dba Jiffy Lube #2803 (“Jiffy Lube”)
3 and their respective counsel (collectively, “the Parties), that the date for filing
