2 File Confidential Agreements Under Seal and the Declaration of Paul Alston in Support of The
3 Kamehameha Schools Defendants and Cross-Defendants' Motion to Dismiss and For Leave to
4 File Confidential Agreements Under Seal, and good cause appearing, hereby finds:

5 Exhibits 23 and 24 which The Kamehameha Schools Defendants and Cross-Defendants
