Due to the appeal that is now pending before the Ninth Circuit Court of Appeals in the matter of *Video Gaming Technologies v. Bureau of Gambling Control*, et al., (USCA Case No. 09-16092), and because the appeal has the potential to dispose of this case, the parties to this action on August 31, 2009, stipulated to extending certain deadlines and benchmark dates under this Court's Scheduling Order entered on or about October 7, 2008.
