To: The Director of the California Department of Corrections and Rehabilitation, 1515 S Street, Sacramento, California 95814.

Plaintiff, a state prisoner proceeding pro se and in forma pauperis, is obligated to pay the statutory filing fee of \$350.00 for this action. Plaintiff has been assessed an initial partial filing fee of \$1.77 for this action pursuant to 28 U.S.C. § 1915(b)(1). Upon payment of that initial partial filing fee, plaintiff will be obligated to make monthly payments in the amount of twenty percent of the preceding month's income credited to

1 plaintiff's trust account. The California Department of
2 Corrections and Rehabilitation is required to send to the Clerk of
3 the Court the initial partial filing fee and thereafter payments
4 from plaintiff's prison trust account each time the amount in the
5 account exceeds \$10.00, until the statutory filing fee of \$350.00
6 is paid in full. 28 U.S.C. § 1915(b)(2).

7 Good cause appearing therefore, IT IS HEREBY ORDERED that:

8 1. The Director of the California Department of Corrections
9 and Rehabilitation or a designee shall collect from plaintiff's
10 prison trust account an initial partial filing fee in the amount of
11 \$1.77 and shall forward the amount to the Clerk of the Court. Said
12 payment shall be clearly identified by the name and number assigned
13 to this action.

14 2. Thereafter, the Director of the California Department of
15 Corrections and Rehabilitation or a designee shall collect from
16 plaintiff's prison trust account the \$348.23 balance of the filing
17 fee by collecting monthly payments from plaintiff's prison trust
18 account in an amount equal to twenty percent (20%) of the preceding
19 month's income credited to the prisoner's trust account and
20 forwarding payments to the Clerk of the Court each time the amount
21 in the account exceeds \$10.00 in accordance with 28 U.S.C. §
22 1915(b)(2). The payments shall be clearly identified by the name
23 and number assigned to this action.

24 3. The Clerk of the Court is directed to serve a copy of this
25 order and a copy of plaintiff's signed in forma pauperis affidavit
26 on Director, California Department of Corrections and
27 Rehabilitation, 1515 S Street, Sacramento, California 95814.

28 4. The Clerk of the Court is directed to serve a copy of this

1 order on the Financial Department of the court.
