18 IT IS HEREBY STIPULATED, by and between the parties, through their respective
 19 counsel of record, that this action be remanded to the Commissioner of Social Security for
 20 further administrative action pursuant to section 205(g) of the Social Security Act, as amended,
 21 42 U.S.C. § 405(g), sentence four.

22 On remand, the Appeals Counsel will instruct the Administrative Law Judge (“ALJ”) to
 23 take the following action:

24 Update the medical record with evidence from the treating sources to clarify the severity
 25 of the claimant's physical and mental impairments, including medical source statements; evaluate
 26 all of the medical source opinions of record, including those of Dr. Budham and the State agency
 27 physicians; obtain, if warranted, a consultative psychiatric examination with psychological
 28 testing and medical source statements; evaluate the severity of any mental impairment pursuant

1 to 20 CFR § 416.920a; re-evaluate Plaintiff's credibility and residual functional capacity; and
2 determine whether Plaintiff can return to her past relevant work and/or a significant number of
3 other jobs in the national economy, obtaining vocational expert testimony if necessary.

4 The parties further request that the Clerk of the Court be directed to enter a final
5 judgment in favor of plaintiff, and against defendant, Commissioner of Social Security, reversing
6 the final decision of the Commissioner.
