1 **STIPULATION**

2 This stipulation is entered into by and among plaintiff Stanley Swenson (“plaintiff”) and

4 DeMarco, Don Langford, Bill Hoy, Marcia Armstrong, Jim Cook, Ron Stevens, Jeff Fowle, Chris

6 respective attorneys of record, pursuant to the Federal Rules of Civil Procedure, Rule

14 Langford shall bear their own costs in this matter, without prejudice to the remaining parties’
15 rights to claim such recoveries against each other, if appropriate.
