 20 IT IS HEREBY STIPULATED, by and between the parties, through their respective counsel of  
 21 record, that this action be remanded to the Commissioner of Social Security for further administrative  
 22 action pursuant to section 205(g) of the Social Security Act, as amended, 42 U.S.C. § 405(g), sentence  
 23 four.

24 Upon remand, the Office of Disability Adjudication and Review will direct the Administrative  
 25 Law Judge to propound a complete hypothetical question to the vocational expert that includes all of  
 26 Plaintiff's limitations with regard to her ability to interact with co-workers and supervisors.
