14	Before the Court is <i>pro se</i> state prisoner Plaintiff Cleo Westerfield's Application to Proceed In Forma Pauperis (Ct. Rec. 5),
15	filed October 30, 2008. Plaintiff seeks relief pursuant to 42 U.S.C.
16	§ 1983.
17	After review, IT IS HEREBY ORDERED:
18	1. Plaintiff's Application to Proceed In Forma Pauperis
19	(Ct. Rec. 5) is GRANTED.
20	2. Because the Petition appears to be duplicative of a petition
21	originally filed on August 21, 2008 and pending in the Eastern
22	District of California, Sacramento Division under Civil Case number
23	08-1970-RCF, the Petition before this Court is DISMISSED . The Court
24	may dismiss a duplicative petition as frivolous under the authority of
25	28 U.S.C. § 1915(d) if it "merely repeats pending or previously
26	litigated claims." Cato v. United States, 70 F.3d 1103, 1105 n. 2

1	(9th Cir. 1995) (citations omitted). Thus, the current petition is
2	subject to dismissal as duplicative. Plaintiff is cautioned that
3	unless he is under imminent danger of serious physical injury, a
4	prisoner may not bring a subsequent in forma pauperis action in the
5	district court if, while incarcerated, he has brought three or more
6	actions which were dismissed by the Court prior to service pursuant to
7	28 U.S.C. § 1915. <i>See</i> 28 U.S.C. § 1915(g).
8	Accordingly, the Court GRANTS Petitioner's request to proceed in
9	forma pauperis and DISMISSES the petition with prejudice to
10	reasserting the specified claims in another unpaid complaint.
11	IT IS SO ORDERED. The District Court Executive is directed to
12	enter this Order and forward a copy to Plaintiff.
