21 Examination of the above-entitled actions reveal that these
22 actions are related within the meaning of E.D. Cal. Local Rule 83-
23 123. Accordingly, the assignment of the matters to the same judge
24 and magistrate judge is likely to affect a substantial savings of
25 judicial effort and is also likely to be convenient for the
parties.

26 The parties should be aware that relating the cases under
27 Local Rule 83-123 merely has the result that these actions are
28 assigned to the same judge and magistrate judge; no consolidation

1 of the actions is effected. Under the regular practice of this
2 court, related cases are generally assigned to the judge and
3 magistrate judge to whom the first filed action was assigned.

4 IT IS THEREFORE ORDERED that the action denominated CIV. NO.
5 2:09-CV-00111-WBS-DAD be reassigned to Judge John A. Mendez and
6 Magistrate Judge Gregory G. Hollows for all further proceedings,
7 and any dates currently set in this reassigned case only are hereby
8 VACATED. Henceforth, the caption on documents filed in the
9 reassigned case shall be shown as CIV. NO. 2:09-CV-00111-JAM-GGH.

10 IT IS FURTHER ORDERED that the Clerk of the Court make
11 appropriate adjustment in the assignment of civil cases to
12 compensate for this reassignment.
