4 Examination of the above-entitled actions reveal that these  
5 actions are related within the meaning of E.D. Cal. Local Rule 83-

18 Magistrate Judge Gregory G. Hollows for all further proceedings,  
19 and any dates currently set in this reassigned case only are hereby  
20 VACATED. Henceforth, the caption on documents filed in the  
21 reassigned case shall be shown as CIV. NO. 2:09-CV-00151-JAM-GGH.

22 IT IS FURTHER ORDERED that the Clerk of the Court make  
23 appropriate adjustment in the assignment of civil cases to  
24 compensate for this reassignment.
