and forwarded by the appropriate agency to the Clerk of the Court each time the amount in 1 2 plaintiff's account exceeds \$10.00, until the filing fee is paid in full. 28 U.S.C. 3 § 1915(b)(2). 4 The complaint states a cognizable claim for relief pursuant to 42 U.S.C. § 1983 5 and 28 U.S.C. § 1915A(b). If the allegations of the complaint are proven, plaintiff has a 6 reasonable opportunity to prevail on the merits of this action. 7 In accordance with the above, IT IS HEREBY ORDERED that: 8 1. Plaintiff's request for leave to proceed in forma pauperis is granted. 9 2. Plaintiff is obligated to pay the statutory filing fee of \$350.00 for this action. 10 The fee shall be collected and paid in accordance with this court's order to the Director of the 11 California Department of Corrections and Rehabilitation filed concurrently herewith. 12 3. Service is appropriate for the following defendants: Stocker, Sahota, Grannis, Warden of Folsom Prison. 13 14 4. The Clerk of the Court shall send plaintiff 4 USM-285 forms, one summons, 15 an instruction sheet and a copy of the complaint filed November 26, 2008. 16 5. Within thirty days from the date of this order, plaintiff shall complete the 17 attached Notice of Submission of Documents and submit the following documents to the court: 18 a. The completed Notice of Submission of Documents; 19 b. One completed summons; c. One completed USM-285 form for each defendant listed in number 3 20 21 above; and 22 d. Five copies of the endorsed complaint filed November 26, 2008. 23 ///// 24 ///// 25 /////
