19 WHEREAS, these consolidated civil cases arise from alleged antitrust violations to fix the
 20 prices of processed tomato products; and

21 WHEREAS, at the May 30, 2013 Status Conference the parties informed the Court that
 22 plaintiffs and defendants Ingomar Packing Company (“Ingomar”), Los Gatos Tomato Products
 23 (“Los Gatos”), Gregory Pruett and Stuart Woolf had reached agreements in principle to settle;
