5	relating to EAJA fees in connection with this action. Any payment shall be made payable to Plaintiff's	
6	counsel as Plaintiff's assignee and delivered to Plaintiff's counsel.	
7	This award is without prejudice to the rights of Plaintiff's counsel to seek Social Security Act	
8	attorney fees under 42 U.S.C. § 406, subject to the provisions of the EAJA.
