16	Plaintiff is a state prisoner proceeding pro se. Plaintiff seeks relief pursuant to 42				
17	U.S.C. § 1983 and has requested leave to proceed in forma pauperis pursuant to 28 U.S.C.				
18	§ 1915. This proceeding was referred to this court by Local Rule 72-302 pursuant to 28 U.S.C.				
19	§ 636(b)(1).				
20	Plaintiff has submitted a declaration that makes the showing required by 28				
21	U.S.C. § 1915(a). Accordingly, the request to proceed in forma pauperis will be granted.				
22	Plaintiff is required to pay the statutory filing fee of \$350.00 for this action. 28				
23	U.S.C. §§ 1914(a), 1915(b)(1). By this order, plaintiff will be assessed an initial partial filing fee				
24	in accordance with the provisions of 28 U.S.C. § 1915(b)(1). By separate order, the court will				
25	direct the appropriate agency to collect the initial partial filing fee from plaintiff's trust account				
26	and forward it to the Clerk of the Court. Thereafter, plaintiff will be obligated for monthly				
	1				

payments of twenty percent of the preceding month's income credited to plaintiff's prison trust
 account. These payments will be forwarded by the appropriate agency to the Clerk of the Court
 each time the amount in plaintiff's account exceeds \$10.00, until the filing fee is paid in full. 28
 U.S.C. § 1915(b)(2).

The complaint states a cognizable claim for relief pursuant to 42 U.S.C. § 1983
and 28 U.S.C. § 1915A(b). If the allegations of the complaint are proven, plaintiff has a
reasonable opportunity to prevail on the merits of this action.

In accordance with the above, IT IS HEREBY ORDERED that:

1. Plaintiff's request for leave to proceed in forma pauperis is granted.

2. Plaintiff is obligated to pay the statutory filing fee of \$350.00 for this action.
 Plaintiff is assessed an initial partial filing fee in accordance with the provisions of 28 U.S.C.
 § 1915(b)(1). All fees shall be collected and paid in accordance with this court's order to the
 Director of the California Department of Corrections and Rehabilitation filed concurrently
 herewith.

15 3. Service is appropriate for the following defendants: Mike Knowles; V. Kahle;
16 J. P. Gonzalez; and N. Grannis.

4. The Clerk of the Court shall send plaintiff four USM-285 forms, one
summons, an instruction sheet and a copy of the complaint filed December 31, 2008.

19 5. Within thirty days from the date of this order, plaintiff shall complete the20 attached Notice of Submission of Documents and submit the following documents to the court:

a. The completed Notice of Submission of Documents;

b. One completed summons;

c. One completed USM-285 form for each defendant listed in number 3 above; and

d. Five copies of the endorsed complaint filed December 31, 2008.
