Motion for Protective Order and Leave

1 Having considered Plaintiffs’ Motion for Protective Order and Leave to File Documents
2 Under Seal, the memorandums in support and opposition, the Court being fully advised, and
3 good cause shown:

4 **IT IS HEREBY ORDERED** that Plaintiffs’ Motion for Protective Order and Leave to
5 File Documents Under Seal is **GRANTED**; Plaintiffs have demonstrated that compelling
6 justification exists to warrant the issuance of a protective order and for leave to file documents
7 under seal.

8 **IT IS ORDERED** that:

9 (1) Plaintiffs ProtectMarriage.com, NOM-California, and the Class of Major Donors
10 may file any declaration of any individual or organization that supported
11 Proposition 8 under seal;

12 (2) Plaintiffs ProtectMarriage.com, NOM-California, and the Class of Major Donors
13 may redact any personal information from any and all filings not filed under seal
14 that could be used to identify supporters of Proposition 8 or members of or donors
15 to ProtectMarriage.com or NOM-California;

16 (3) Plaintiffs ProtectMarriage.com, NOM-California, and the Class of Major Donors
17 may file an additional unredacted copy under seal of any document that is
18 redacted pursuant to FRCP 5.2(f), or in the alternative, may file a reference list
19 under seal pursuant to FRCP 5.2(g);

20 (4) Defendants, their agents, servants, employees, officials, or any other person
21 acting in concert with them or on their behalf, are **PROHIBITED** from revealing
22 the name of any individual that supported Proposition 8 or that is a member of or
23 donor to ProtectMarriage.com or NOM-California.
