1. I am a resident of the state of California over 18 years of age, and my statements herein are based on personal knowledge.

2. I supported the passage of Proposition 8.

3. I signed the petition to have Proposition 8 placed on the ballot.

4. In support of the passage of Proposition 8, I donated \$**XXX** to the National Organization for Marriage California – Yes on 8, sponsored by National Organization for Marriage.

5. My two high school aged children also supported Proposition 8 by attending rallies where they held signs in support of the ballot measure.

6. In support of the passage of Proposition 8, I also placed a sign in my yard. I live in a residential neighborhood and my home is on a street that dead ends at a cul-de-sac shortly after my residence.

7. On or about October 24, 2008, the sign was stolen from my yard.

8. I noticed that three other homes on my street also had their signs supporting Proposition 8 removed during this time, as well as many others on adjoining streets.

9. I am ashamed to admit that, although I would have liked to have placed a bumper sticker on my car supporting Proposition 8, I did not do so because of the aggression directed towards family and friends that resulted from their support of Proposition 8.
