I, [REDACTE], make the following declaration pursuant to 28 U.S.C. § 1746:

1. I am a resident of the state of California over 18 years of age, and my statements herein are based on personal knowledge.

2. I supported the passage of Proposition 8.

3. I am the pastor of [REDACTE] Lutheran Church in [REDACTE], California.

4. Prior to the passage of Proposition 8, I stated to my congregation that the Bible supports marriage between one man and one woman, and that the members of my congregation should vote accordingly.

5. Prior to the passage of Proposition 8, an unknown person placed a “Yes on 8” yard sign on the church property, which remained standing on the property until sometime on November [REDACTE], 2008 or November [REDACTE], 2008.

6. Sometime between 10:00 p.m. on November [REDACTE], 2008 and 8:00 a.m. on November [REDACTE], 2008, the “Yes on 8” yard sign that had been placed on the church property and a heavy object, such as a rock, were used to break a large window of our church building. Pictures of the broken window and the “Yes on 8” sign are attached as Exhibit A. These pictures are a true and accurate representation of the broken window and “Yes on 8” sign as I discovered them on November [REDACTE], 2008.

7. Our denominational newspaper of the Lutheran Church, Missouri Synod, published a story about the incident, which is attached as Exhibit B. This account of the events is a true and accurate representation of the events that occurred.
