7 Examination of the above-entitled actions reveals that these 8 actions are related within the meaning of Local Rule 123 (E.D. Cal. 9 2005). Accordingly, the assignment of the matters to the same judge 10 and magistrate judge is likely to affect a substantial savings of 11 judicial effort and is also likely to be convenient for the 12 parties.
