**AMENDED STIPULATION RE
 CONTINUANCE OF DISCOVERY
 DEADLINES; ORDER**

18 THE PARTIES, by and through their respective attorneys of record, hereby stipulate and
 19 request the court order the following:

20 WHEREAS, on April 1, 2009, the Honorable John A. Mendez issued a Status (Pre-trial
 21 Scheduling) Order with discovery and related deadlines.

22 WHEREAS, the discovery deadline and the deadline for filing the Joint Mid-Litigation
 23 Statement are October 9, 2009.

24 WHEREAS, the parties have propounded certain written discovery, but have not yet
 25 responded.

26 WHEREAS, the parties recently completed an inspection of the vehicle at issue in this
 27 case and believe that the case can be settled without incurring the expense inherent in completing
 28 discovery.

3 WHEREAS, the parties have agreed to mediate the case with Gary Garman and are
4 working on obtaining the first available date upon which to hold the mediation.

5 NOW THEREFORE, IT IS HEREBY STIPULATED AND AGREED BY AND
6 BETWEEN COUNSEL FOR THE PARTES HERETO, THE FOLLOWING:

- 7 1. All discovery shall be completed by November 30, 2009;
- 8 2. The parties shall make expert witness disclosures under Fed. R. Civ. P. 26(a)(2)
9 by November 9, 2009, and supplemental disclosure and disclosure of any rebuttal experts under
10 Fed. R. Civ. P. 26(a)(2)(c) shall be made by November 16, 2009;
- 11 3. No later than November 16, 2009, the parties shall file with the court a brief Joint
12 Mid-Litigation Statement;
- 13 4. Dispositive motion filing date: January 6, 2010;
- 14 5. Dispositive motion hearing date: February 3, 2010, at 9:00 a.m.;
- 15 6. Joint pretrial statement due date: March 12, 2010;
- 16 7. Pretrial conference date: March 19, 2010, at 3:00 p.m.; and
- 17 8. Jury trial date: April 26, 2010, at 9:00 a.m.

18 The parties agree to submit this Stipulation to the court and jointly request that the court
19 enter it as an order.

20 For the purposes of this Stipulation, facsimile signatures shall be deemed originals.
