16	Plaintiff is a prisoner who is proceeding pro se and in forma pauperis. Plaintiff
17	seeks relief pursuant to 42 U.S.C. § 1983.
18	On June 16, 2009, the court ordered the United States Marshal to serve the
19	complaint on defendants. Process directed to defendants Deputy Warden of High Desert State
20	Prison and Acting Warden of High Desert State Prison was returned unserved because "unable to
21	accept service without a name." Plaintiff must provide additional information, i.e., he must
22	provide the names of the individuals who are employed as the Deputy Warden and Acting
23	Warden at HDSP, in order for these defendants to be served. Plaintiff shall promptly seek such
24	information through discovery, the California Public Records Act, Calif. Gov't. Code § 6250, et
25	seq., or other means available to plaintiff. If access to the required information is denied or
26	unreasonably delayed, plaintiff may seek judicial intervention.

1	Accordingly, IT IS HEREBY ORDERED that:
2	1. The Clerk of the Court is directed to send to plaintiff 2 USM-285 forms, along
3	with an instruction sheet and a copy of the complaint filed March 16, 2009;
4	2. Within sixty days from the date of this order, plaintiff shall complete and
5	submit the attached Notice of Submission of Documents to the court, with the following
6	documents:
7	a. One completed USM-285 form for each defendant;
8	b. Three copies of the endorsed complaint filed March 16, 2009; and
