Plaintiff is a state prisoner proceeding pro se. He seeks relief pursuant to 42 U.S.C. § 1983. By concurrent Order plaintiff's claims against several other defendants were dismissed with leave to file a second amended complaint.

Plaintiff's complaint states a cognizable claim for relief against defendant Bishop. If the allegations of the complaint are proven, plaintiff has a reasonable opportunity to prevail on the merits of this action.

In accordance with the above, IT IS HEREBY ORDERED that:

1. Service is appropriate for the following defendant: Bishop.
2. The Clerk of the Court shall send plaintiff one USM-285 form, one summons, an instruction sheet and a copy of the complaint filed August 3, 2009.
3. Within thirty days from the date of this order, plaintiff shall complete the

1 attached Notice of Submission of Documents and submit the following documents to the court:

- 2 a. The completed Notice of Submission of Documents;
- 3 b. One completed summons;
- 4 c. One completed USM-285 form for each defendant listed in number 1
- 5 above; and
- 6 d. Two copies of the endorsed complaint filed August 3, 2009.

7 4. Plaintiff need not attempt service on defendants and need not request waiver of
8 service. Upon receipt of the above-described documents, the court will direct the United States
9 Marshal to serve the above-named defendants pursuant to Federal Rule of Civil Procedure 4
10 without payment of costs.
