Plaintiff, Scott N. Johnson, hereby requests an extension of time in which to continue the date to file a joint status conference statement from September 3, 2009 to October 5, 2009. Pursuant to Local Rule 16, Defendants are to be served within 120 days of filing the complaint. This complaint was filed on May 15, 2009; the 120 day time period for service would end on September 15, 2009. Defendants Lyudmila Polyanskaya and Lilya Agarkova Lyubov Polyanskaya were served on June 21, 2009, Defendant

2 Defendants Ross Davidson and Mildred Davis Davidson were
3 served on July 3, 2009. Pursuant to Local Rule 16, the
4 Parties are to confer as required by Fed. R. Civ. P. 26(f)
5 and submit a joint status conference statement within 60
6 days after all Defendants are served. The joint status
7 conference statement would be due September 3, 2009.
8 Plaintiff filed a Stipulation and Proposed Order on August
9 17, 2009 granting Defendants an extension of time to
10 respond to the complaint until September 30, 2009. A
11 continuance of the date for filing a joint status
12 conference statement from September 3, 2009 to October 5,
13 2009 would give the Defendants time to file a response to
14 Plaintiff's complaint.
