**JOINT APPLICATION FOR ORDER
 EXTENDING TIME FOR FILING OF
 DISPOSITIONAL PAPERS**

25 **I. INTRODUCTION**

26 The parties herein, Plaintiff **ETHAN BLANKENSHIP** and Defendant **ALASKA**
 27 **AIRLINES, INC.**, hereby jointly apply to the Court for an Order extending the time for filing of
 28 dispositional papers from the current date of October 18, 2010 through November 19, 2010.

1 The Joint Application is made pursuant to the provisions of Federal Rule of Civil Procedure
2 (“FRCivP”), Rule 16 and Local Rules of the United States District Court, Eastern District of
3 California (“Civil L. R.”), Rule 160(b), and on the grounds the requested extension is necessary in
4 order to allow sufficient time for execution of a Release and Settlement Agreement by the parties,
5 and payment of the settlement amount to Plaintiff by Defendant.

6 **II. STATEMENT OF FACTS**

7 Trial herein is set for February 7, 2011.

8 On September 1, 2010, the parties and their counsel conduct a voluntary mediation with a
9 private mediator, at which time a settlement agreement was reached whereby Plaintiff ETHAN
10 BLANKENSHIP will dismiss the entire action against Defendant ALASKA AIRLINES, INC.,
11 upon payment of the agreed-upon settlement amount.

12 At the time the settlement agreement was reached, it was agreed that a formal document
13 setting forth the terms of the settlement would be prepared and executed by the parties. Defendant
14 represented that it would make reasonable efforts to secure payment of the settlement amount
15 within 30-60 days.

16 The Court’s Order setting October 18, 2010 as the date for filing dispositional documents
17 was entered September 27, 2010.

18 Defendant’s counsel has prepared a Release and Settlement Agreement and provided the
19 Agreement to Plaintiff’s counsel for execution by the Plaintiff. Upon receipt of the executed
20 Agreement, Defendant’s counsel will tender the settlement payment to Plaintiff’s counsel.
