18 IT IS HEREBY STIPULATED by the parties, through their undersigned attorneys, and
 19 with the approval of the Court as provided below, that the Commissioner has agreed to a voluntary
 20 remand of this case pursuant to sentence four of 42 U.S.C. § 405(g) for further proceedings.

21 Upon remand, the ALJ must address all of the medical source opinion evidence of record
 22 and he must explain the weight he attributes to each source under the terms of 20 C.F.R. § 404.1529 and
 23 Social Security Ruling 06-03p.

24 It is further stipulated that the administrative decision is hereby vacated and that the Clerk


