Payment of THREE THOUSAND SEVEN HUNDRED dollars and 00/100 cents 25 (\$3,700.00) in EAJA attorney fees, shall constitute a complete release from and bar to any and all 26 claims Plaintiff may have relating to EAJA fees in connection with this action. Any payment 27 28

1	shall be made payable to Plaintiff's counsel as Plaintiff's assignee and delivered to Plaintiff's	
2	counsel.	
3	This award is without prejudice to the rights of Plaintiff's counsel to seek Social Security	
4	Act attorney fees under 42 U.S.C. § 406, subject to the provisions of the EAJA.
