2 1. This action was filed on February 2, 2009, but then was removed to U.S. District
3 Court on or about July 30, 2009;

4 2. After the parties filed the Joint Status Report on or about September 28, 2009, the
5 Court issued its Status (Pre-Trial Scheduling) Order, by which the Court set the trial date of this
6 action for December 6, 2010;

7 3. The Court's September 30, 2009, Status (Pre-trial Scheduling) Order also set the
