1                   **ORDER:**

2                   Upon stipulation of the parties, and good cause appearing, IT IS HEREBY  
3 ORDERED that:

4                   1.       Service of the Summons, the Complaint, the Order Requiring Joint Status  
5 Report, the Notice of Availability of Voluntary Dispute Resolution, and the Notice of  
6 Availability of Magistrate Judge to Exercise Jurisdiction and Appeal Instructions on all  
7 Defendants and the Nominal Defendant (collectively, "Defendants") shall be deemed  
8 good and sufficient.

9                   2.       Defendants shall have 60 days from the date of the stipulation upon which  
10 this order is based to answer or move with respect to the Complaint. In the event that  
11 Defendants move to transfer this case to a different district, then their time to answer  
12 or move with respect to the Complaint shall be extended until 30 days after the entry of  
13 an order of the Court determining the motion to transfer.

14                   3.       The Order Requiring Joint Status Report is hereby modified so as to  
15 extend the time of the parties to submit such a report until 60 days after (i) the  
16 determination of any motion addressed to the Complaint or (ii) the filing of any  
17 answer, whichever occurs earlier.
